ELIGIBILITY: DSHS-Licensed EMS Agencies



- The **Texas Cardiac Arrest Registry to Enhance Survival** is used to improve the quality of care for cardiac arrest patients by reporting and measuring outcomes throughout the State of Texas
- **EMS agency enrollment** – destination hospitals must be willing to provide outcome data
- Should have **RPPA/BAA** on file with NCTTRAC – for data sharing/best practices development

ELIGIBILITY: DSHS-Licensed EMS Agencies, First Responders Organizations (FROs), and Hospitals

- The **Honeywell BW Clip Gas Detector CO 35 – 200** is a professional grade, portable instrument that alerts to the presence of carbon monoxide gas
