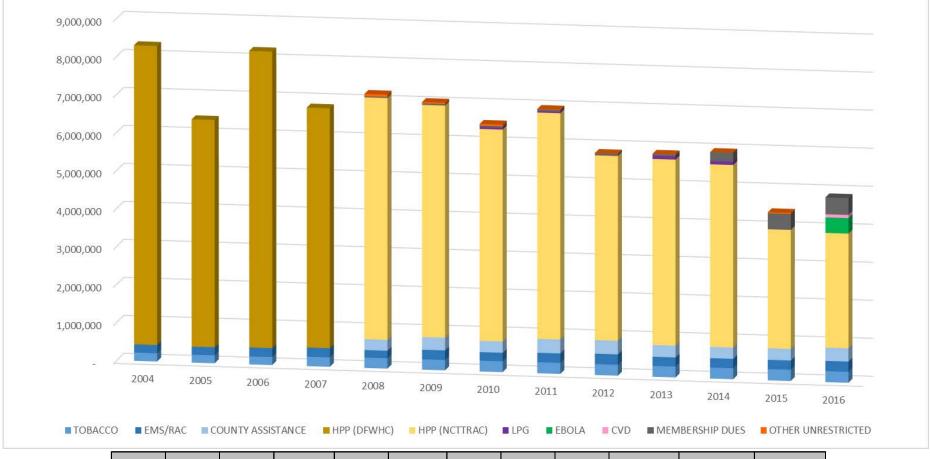

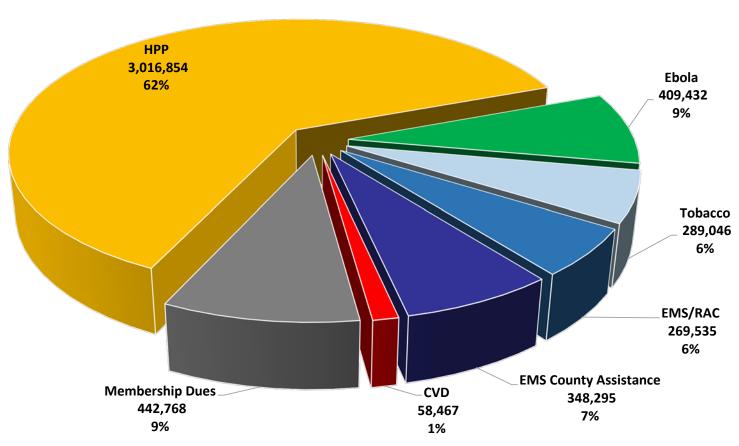

2017 HPP Program Continuation

- DSHS announced expectation to receive funding opportunity announcement (FOA) for HPP program continuation past June 30, 2017
- Process:
 - State submits response to a request for proposal (RFP) to get grant contract
 - About January 2017 state issues RFP soliciting regional contractor proposals
 - Spring 2017 contractors selected for July 1, 2017 start of the 5 five-year block
- Level funding predicted

Ebola Preparedness & Response Program (EPRP)

- World Health Organization declared end of Ebola public health emergency internationally on March 29, 2016
 - Travel restrictions and tracking lifted December 29, 2015
 HOWEVER
- 7 of 9 new cases in Guinea last week resulted in death
- Liberia has closed its borders with Guinea
- MERS-CoV: 34 cases in Saudi Arabia in March
 - 11 known dead

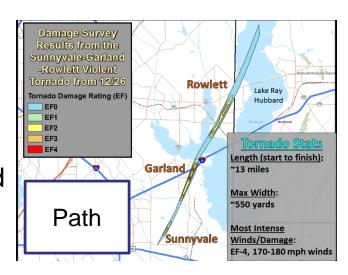

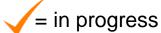

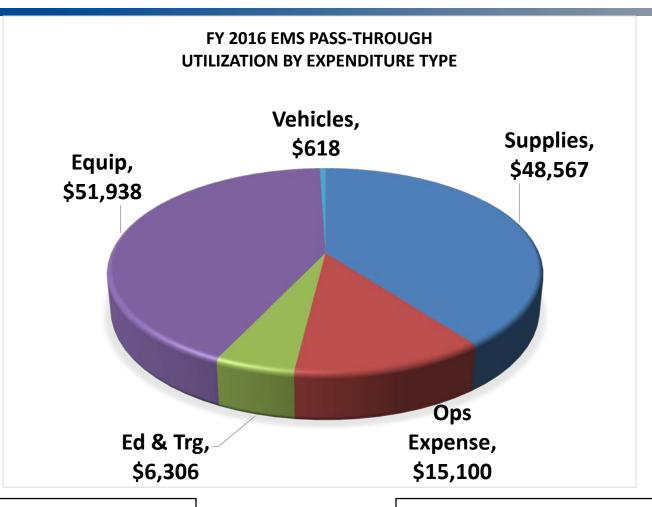

Compliance Status

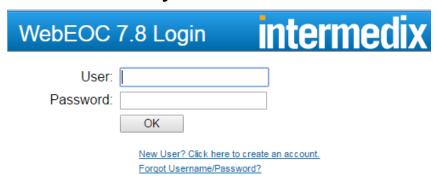
- 100+ BAAs and RPPAs completed and verified!
 - HCA (10 hospitals) and THR (15 hospitals) each signed a corporate agreement
 - 120 sites covered to date, including 21 Trauma Centers
- Several engaged with Compliance and Legal
 - Ex: Baylor, Dallas FD
- Data to be cleared from system for only a small number of sites
 - Those that have requested copies of their data will sent encrypted DVDs

Injury Prevention Public Education

- With the cessation of data submission to the RAC, I have submitted a request for a report of specific injury data from the state registry for RAC E—anticipate receiving it by the May meeting
- The committee participated in a webinar supported by the CDC and The Society for Advancement of Violence and Injury Prevention Research (SAVIR). The webinar is a first in a series that pays particular attention to the ACS verification standards for injury prevention initiatives in hospital settings as outlined by the Orange book.



Injury Prevention Public Education

- The committee had GETAC updates and current violence and injury prevention activities by various committee members
- Currently the committee is working on the 2016 needs
 assessment questions to be included in the RAC's annual effort
 and discussing committee participation requirements as outlined
 by the state.
- The committee is in full support of the Hartford Consensus Report Stop the Bleed, and is waiting for the go-ahead to begin an organized regional approach. In the state of Texas, firearms is one of the top five mechanisms of injury.

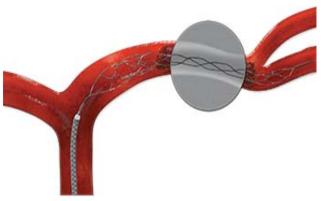
